Details of local arrangements:					

Class and Year Group Bubbles

- From March 8th, pupils will again be taught in class group bubbles, where lessons will be delivered in one classroom by one teacher, whenever possible.
- At Beech Avenue, smaller groups the size of a full class will be used where possible. Where this is not possible, year-group bubbles will operate.
- For break times and lunch times and some wave 2/3 interventions class groups may mix with a larger year group bubble. This will help to reduce the number of people who could be asked to isolate should someone in group become ill with coronavirus (COVID-19).
- Pupils will be kept in their class groups for most of their curriculum time. However, mixing into wider year group bubbles will be allowed for specialist teaching of subjects like Phonics and for Interventions.
- Phonics ability set bubbles will be created across the Reception year groups and ability year group bubbles across Year 1 and 2. Staff leading these will be expected to keep socially distant from the pupils.
- Class groups and Year Group Bubbles will be kept apart from other groups where possible and older children will be encouraged to keep their distance within groups.
- Leaders will take steps to limit interaction, sharing of rooms and social spaces between groups as much as possible.
- Screens will be put in the dining room so that an additional year group can eat together. This will cut down lunch times.

Teaching Assistant deployment in classrooms

- Where there are TAs in the classroom, Phase Leads and Teachers will identify the intervention most needed and ensure their TA is supporting in delivering this.
- Given the nature of the TA role, 1:1 support is required and can last for extended periods.
- TAs will be reminded not to share equipment and to work alongside pupils instead of face on.
- Where TAs are moving across year groups, they will socially distance where possible.
- Anti-bac will be used before and after working with each group.
- If TAs use additional spaces around school for intervention, they will be asked to clean the area after use after use.

Interventions

- Adults from across different bubbles will be able to deliver interventions to pupils from the same bubble (class or year group).
- They will be expected to adhere to social distancing rules.
- Interventions will be planned by Assistant Heads/Phase Leads and where possible, adults will work within their year group bubbles.

- In order to accommodate both Primary and Secondary Phase staggered lunches, it has been necessary to reduce lunchtime to 20 minutes for pupils in Years 1 – 5. An additional 10-minute afternoon play session has been introduced for these year groups.
